

# INSTRUCTIONS FOR Voter Affidavit For Write-in Ron Paul & Printed Ballot For Other Minor Party & Independent Candidates

Step #2 - VOTE YOUR CONSCIENCE

Step #3 - Make & Send In your notarized AFFIDAVIT

**NOTE: If you have already voted by Absentee Ballot or Early voting then go to step #C)**

- A. **Vote IN--PERSON** at a local polling place before Election Day, where offered, ----- or on Election Day.
- B. **Write--In Ron Paul for President (or the liberty candidate of your choice)** on your ballot. If your candidate appears is on the ballot, you can vote for your candidate instead of writing them in.
- C. **The day after the election (not before, but at least within 2 weeks of the election), fill out the below AFFIDAVIT FORM** & take it to a notary public at your local bank or elsewhere, & SIGN your affidavit only AFTER you are in front of the notary . Don't delay.
- D. **Submit a COPY of your affidavit to WritelnREVOLUTION** by one of these methods (not before, but the day after the election at least within 2 weeks of the election):

**UPDATE:** It has been brought to our attention that some State's have passed what we believe are draconian & unconstitutional laws making it a crime to reproduce a copy of your own ballot & let others see it. We are now suggesting just filing the affidavits since the copies of the ballots are NOT the important part of this strategy. It is the affidavits under oath that give us the legal instruments to confront false vote counts in the precincts. We suggest you use your own judgment but we at WritelnRevolution are not advocating anyone commit any crimes. However, the forces against liberty demand at some point that the people say 'enough is enough, we will not tolerate tyranny'.

**NOTE:** To the best of our knowledge, after extensive research, we believe the following States will accept & 'count' 'write in' ballots for Ron Paul. Some States say they will count them by name, but only if the total number of 'write in' ballots counted together are in large enough number to affect the outcome of the election. **Therefore we advise all voters to directly contact your county Board of Elections or Secretary of State for current policy information details.** We also urge you to demand your state to repeal any unconstitutional ballot restriction policies that infringe upon your voting rights. Dr. Paul stated that if we do write his name in, to "hold their feet to the fire and make them count them".

#### State Update:

**Alabama** - (no registration required for write in votes); **California** - (Ron Paul/Napolitano now listed on CA SOS site with 55 Electors as registered as a write in candidate) ; **District of Columbia; Delaware; Iowa** - (no registration required for write in votes); **Maine** - (Ron Paul is registered with Electors on the SOS site as a write in candidate); **Maryland; New Hampshire** - (no registration required for write in votes); **New Jersey** - (no registration required for write in votes); **Oregon; Pennsylvania** - (no registration required, but rules permit each County to decide if to count write in candidates); **Rhode Island; Vermont** - (no registration required for write in votes); **Washington; Wisconsin; Wyoming** - (no registration required for write in votes)

**Please Note: Affidavits are requested from voters in ALL 50 states. Though this protest effort is largely symbolic, the affidavits could product evidence of fraud on the precinct level & force hand recounts of entire counties.
